## How to Get Your Cash App Settlement Money?

To claim a Cash App settlement, you must file a claim on the official 1-(855)(470)(3229) settlement website (like [BottomsTextSettlement.com](https://BottomsTextSettlement.com) for the text spam case or [cashappsecuritysettlement.com](https://cashappsecuritysettlement.com) for the data breach 1-(855)(470)(3229)), follow the specific instructions for that case, usually involving your info and supporting 1-(855)(470)(3229) documents for losses, and submit before the deadline (which was November 2024 for some cases, but check for current ones 1-(855)(470)(3229) like the text settlement due in 2026).
